What information we collect and how we use it

We receive, collect and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page. We also collect personally identifiable information (including name, email, password, communications); payment details (including credit card information), comments, feedback, product reviews, recommendations, and personal profile.

Methods of Collection

When you conduct a transaction on our website, as part of the process, we collect personal information you give us such as your name, address and email address. In addition, we automatically collect the Internet protocol (IP) address used to connect your computer to the Internet. Your personal information will be used for the specific reasons stated above only.

Child Privacy

Information Disclosure
